ADULT EDUCATION: LEGACY MISSION VILLAGE PROVIDES ADULT EDUCATION PROGRAMMING DESIGNED TO SUPPORT REFUGEES IN GAINING THE LANGUAGE AND PRACTICAL SKILLS NECESSARY FOR SUCCESSFUL INTEGRATION INTO AMERICAN SOCIETY. OFFERINGS INCLUDE LEVELED ENGLISH AS A SECOND LANGUAGE (ESL) CLASSES, GED PREPARATION, CITIZENSHIP INSTRUCTION, AND BASIC COMPUTER SKILLS TRAINING. CITIZENSHIP SERVICES INCLUDE CIVICS EDUCATION, APPLICATION ASSISTANCE, INTERVIEW PREPARATION, AND INDIVIDUALIZED SUPPORT THROUGHOUT THE NATURALIZATION PROCESS. STAFF AND VOLUNTEERS ASSIST PARTICIPANTS WITH COMPLETING REQUIRED FORMS, PREPARING FOR THE CIVICS EXAM, AND BUILDING CONFIDENCE FOR INTERVIEWS. STUDENTS ATTEND AFTER-SCHOOL SESSIONS THAT PROVIDE TUTORING, HOMEWORK ASSISTANCE, AND TARGETED ACADEMIC SUPPORT FOR THOSE WITH INTERRUPTED OR LIMITED PRIOR FORMAL EDUCATION. THE PROGRAM INCLUDES ACT PREPARATION, COLLEGE APPLICATION ASSISTANCE, FAFSA SUPPORT, AND LONG-TERM ACADEMIC AND CAREER PLANNING. STUDENTS ARE GUIDED THROUGH THE U.S. EDUCATION SYSTEM AND SUPPORTED IN SETTING AND ACHIEVING POST-SECONDARY GOALS. IN ADDITION TO ACADEMIC SERVICES, JOURNEY OFFERS ENRICHMENT OPPORTUNITIES SUCH AS COLLEGE VISITS, SERVICE PROJECTS, AND GROUP ACTIVITIES THAT FOSTER SOCIAL DEVELOPMENT AND COMMUNITY ENGAGEMENT. THE PROGRAM IS DESIGNED TO EQUIP STUDENTS WITH THE SKILLS, KNOWLEDGE, AND SUPPORT NETWORKS NEEDED TO SUCCEED ACADEMICALLY AND TRANSITION INTO HIGHER EDUCATION OR THE WORKFORCE.

KRP: THE KINDERGARTEN READINESS PROGRAM SERVES REFUGEE CHILDREN AGES 35 BY PREPARING THEM FOR SUCCESSFUL ENTRY INTO THE U.S. SCHOOL SYSTEM. THE PROGRAM PROVIDES EARLY EXPOSURE TO ENGLISH LANGUAGE LEARNING, CLASSROOM ROUTINES, AND FOUNDATIONAL ACADEMIC AND SOCIAL SKILLS IN A STRUCTURED, SCHOOL-LIKE ENVIRONMENT. THIS DUAL FOCUS ON CHILD AND PARENT PREPARATION HELPS FACILITATE SMOOTHER TRANSITIONS INTO KINDERGARTEN AND LONG-TERM EDUCATIONAL SUCCESS.
